

**BYLAW NO. 327/02**

**BEING A BYLAW OF  
THE MUNICIPAL DISTRICT OF MACKENZIE NO. 23  
IN THE PROVINCE OF ALBERTA**

A BYLAW OF THE MUNICIPAL DISTRICT OF MACKENZIE No. 23, IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF CLOSING A PORTION OF A PUBLIC ROADWAY IN ACCORDANCE WITH SECTIONS 22 AND 606 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER M-26, REVISED STATUTES OF ALBERTA 2000.

**WHEREAS**, Council of the Municipal District of Mackenzie No. 23 has received a request for a road closure in La Crete, subject to road closure proceedings being approved, and

**WHEREAS**, Council of the Municipal District of Mackenzie No. 23 has determined that the public roadway as outlined on Schedule A attached hereto, be subject to a road closure to allow the expansion of 100<sup>th</sup> Street to a 4-lane road, and

**WHEREAS**, notice of intention of the Council to pass a bylaw has been published in the Northern Pioneer and Echo on the 18<sup>th</sup> and 25<sup>th</sup> of September, the last of such publications being at least five days before the day fixed for the passing of the bylaw, and

**WHEREAS**, Council of the Municipal District of Mackenzie No. 23 was not petitioned for an opportunity to be heard by any person prejudicially affected by the bylaw.

**NOW THEREFORE**, be it resolved that the Council of the Municipal District of Mackenzie No. 23 does hereby close a portion of the roadway described as follows, subject to the rights of access granted by other legislation or regulations:

1. That all that portion of 100A Street located east of 100 Street in the Hamlet of La Crete, and lying between 98<sup>th</sup> and 94<sup>th</sup> Avenues within Plan Number 762 0383, being 20.12 metres (66.01 feet) in width and 343.78 metres (1127.89 feet) in length plus corner cut-offs, a total of 0.70 hectares or 1.73 acres, be subject to a road closure.
2. That all lots created by the closure of 100A Street be sold to the adjacent property owner for the purpose of providing access to 100 Street.
3. That this Bylaw shall come into effect upon the passing of the third and final reading of this Bylaw.

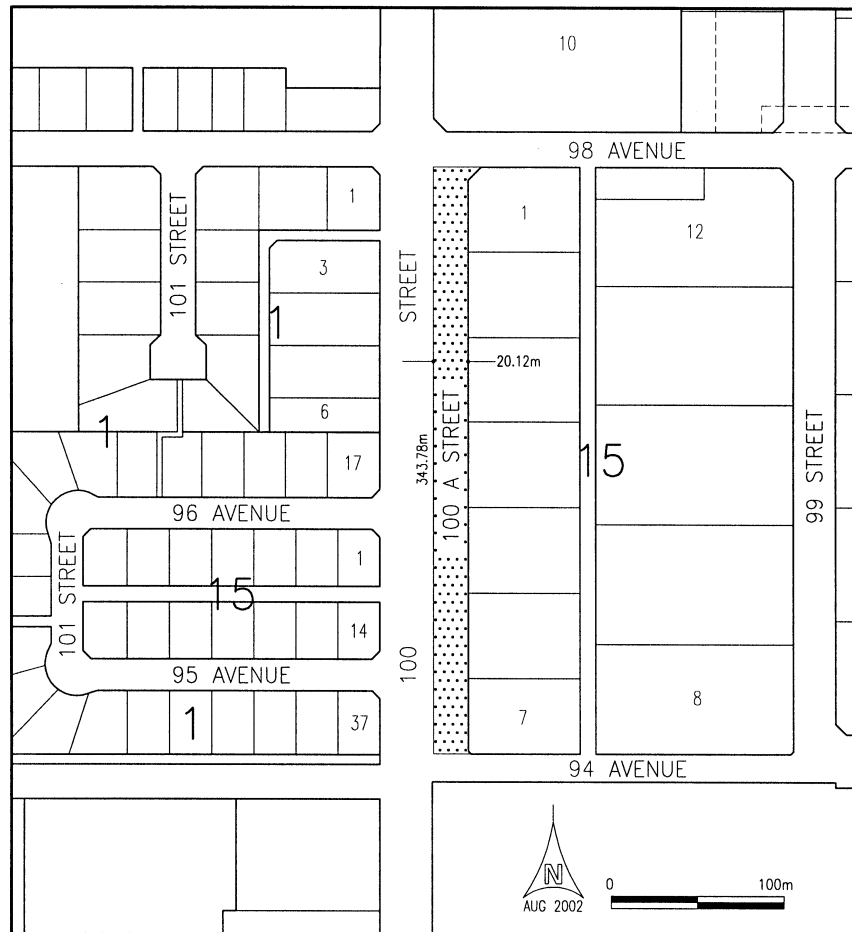
