Councillor Wieler – Regional Economic Development Initiative in High Level, attacking social problems on a regional basis, organizational structure will be conducted in the future, the entire northern region participated.

Councillor Kulscar – Regional Economic Developemtn Inititative, impressed that they are identifying social issues. Police Task Force, policing review document completed, discussed what is the role of our Special Bylaw Officers, want to bring back a request regarding where we want our officers to work. The meeting focused on providing training for the department however there is still a need for volunteers. The discussion resulted in people volunteering again. The community wants an ambulance stationed there.

Gord Burnell stated that there were misquotes in the newspaper and he has written a thank you letter to the Zama Fire Department.

Paul Driedger reported that there are approximately 12 calls per year from Zama where the person needs to be taken to a hospital.

Gord Burnell reported that Advanced Life Support is not required in Zama. A good solution would be to place an Emergency Medical Responder in Zama or place an Emergency Medical Technician into the community.

Rob Barone reported on the protocol of Aeromedical response to calls from Zama.

Reeve Neufeld thanked the delegation who then left the meeting at 2:11 p.m.

Discussion ensued regarding the Memorandum of Understanding. Dangers to the M.D. of Mackenzie must be identified and an action plan established. Council only has one seat on the Cooperative Management Planning Board and needs to negotiate more positions on the Board.
