Mrs. Zaw-Tun explained that a lot of fundraising events for the Library are already happening. Some are planned for the fall. These fundraising events only date up to the end of December, 1996. They are applying for the Community Facility Enhancement Grant and the Alberta Library Book Purchase Grant.

The Library would like a letter of support from the M.D. of Mackenzie No. 23, and hope they can get a letter by June 3, 1996 to go along with their Community Facility Enhancement Grant application.

The Library would like to get the exterior done by October, 1996. They would like to get the fifty percent from the Enhancement Grant and the rest from volunteered labour and fundraising.

The Library would like to ask a M.D. Councillor to volunteer for a head shaving fundraising event.

Anne Martens advised that due to the recent changes in local government because of incorporation of the Improvement District to the Municipal District, Alberta Community Development requires that the M.D. Council develop a Library Board. Any questions regarding this should be forwarded to Alberta Community Development.

The per capita would increase for the Municipal District if they joined the Peace Library Board. It consists of representatives from all communities. These representatives would set policies and would act as a local advisory council for the Library Board.

The library must apply for the funding through the Municipal District. The biggest change for the Municipal District is establishing a Library Board.

Alberta Libraries strongly want all libraries to belong to this system - (First Organizational Chart).

The Library already has some services provided by Alberta Libraries from their central office in Grande Prairie
