BYLAW NO. <u>145/98</u>

BYLAW OF THE MUMCIPAL DISTRICT OF MACKENZIE NO.23 IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF CLOSING AND LEASING A PORTION OF PUBLIC ROAD IN ACCORDANCE WITH SECTION 22 AND 606 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER 31, STATUTES OF ALBERTA, 1994, AS AMENDED.

WHEREAS, the public road described hereafter will not be required for public travel, and

WHEREAS, the Municipal District wishes to lease a portion of the subject public road to the Government of Alberta for use as part of a forest fire suppression base, and

WHEREAS, a notice of intention of the Council to pass a bylaw has been published in a locally circulated newspaper the weeks of September 23, 1998 and September 30, 1998, the last of which such publications being at least 5 days before the date fixed for the passing of this bylaw, and

WHEREAS, Council was not petitioned for an opportunity to be heard by any person prejudicially affected by the bylaw, and a public hearing was held on October 14,1998 where all parties claiming to be affected were present and were heard by Council.

NOW THEREFORE, be it resolved that the Council of the Municipal District of Mackenzie No.23 does hereby close a portion of the public road described as follows and as shown on Schedule "A" and lease a portion of it to the Government of Alberta, subject to the rights of access granted by other legislation or regulations:

All that portion of the undeveloped road allowance commencing at the northeast corner of the River Lot 1, Range 1 (108-12-W5M) thence westerly to a point 117 metres westerly from the east boundary of Riverlot 3, Range 1 (108-12-W5M) in the Municipal District of Mackenzie No. 23. EXCEPTING THEREOUT ALL MINES AND MINERALS


