#### General Highlights:

An increase in subdivision and development enquiries has occurred over the course of the
past few weeks. While this is not unusual for this time of year, the number of enquiries has
increased in comparison to the past few years.

Unauthorized development is being followed up on by the Bylaw Enforcement Officer.

#### Ongoing Projects:

- County Land Use Bylaw. Final revisions will be completed as directed by Council and public notice completed in accordance with Municipal Government Act prior to Public Hearing and Second and Third Reading.
- Draft General Municipal Improvements Standards. The management team intends to review the document and complete necessary revisions prior to presentation to Council.
- Safety Codes Service Contract. Administration negotiations with Superior Safety Codes for a one year contract extension remains underway. Further negotiations regarding fees for service are needed.
- Draft Airport Vicinity Protection Area (AVPA). This matter has been rescheduled to be addressed after the adoption of the Land Use Bylaw.
- Subdivision review of by Stewart Weir has been rescheduled to be addressed later in the year.
   The intent in this process is to review the outstanding items/requirements of the outstanding subdivisions and form a plan for resolution.
- Updating and consolidating of the La Crete Hamlet maps. Technical problems have prevented this matter from being completed however staff is meeting on May 12, 2011 in an effort to resolve the matter.
- At the direction of the Municipal Planning Commission (MPC), Administration is conducting a
  review of the Municipal Reserve Policy RESV 10. The intent of this review is to bring back
  options for the calculation of Municipal Reserve (money in lieu of land). The matter was
  presented to the MPC on April 20, 2011 where it was tabled for further research.
- At the direction of the MPC, Administration is researching a policy intended to prevent the

  deficiencies. The intent of this policy is to provide an incentive to developers to complete their
  development to the required specifications and to prevent the existing problems from being
  compounded upon. Research by staff strongly suggests that this type of policy is contrary to
  the Municipal Government Act however further research is being conducted.
- The matter of the access/road to Part of SE 26-104-14-W5M (Plan 002 3789, Block 1, Lot 1) is ongoing.
- First quarter Subdivision and Development statistical reports. These reports are intended to be presented to Council on May 31, 2011.



#### **BACKGROUND / PROPOSAL:**

Council established Bylaw 658/07 that authorizes a local improvement charge for the curb, gutter and sidewalk construction in the Hamlet of Fort Vermilion (Mackenzie Housing Road Reconstruction project). The project was completed in 2008. The levy was charged in 2009 & 2010.

#### **OPTIONS & BENEFITS:**

Mackenzie Housing subdivided two lots that were part of Bylaw 658/07 for the construction of curb, gutter and sidewalk. The Municipal Government Act section 402 provides authority to Mackenzie County to amend a local improvement where there is a subdivision affecting a parcel of land. That local improvement costs be redistributed to the affected parcels of land.

During the Bylaw review due to the above mentioned subdivision, administration found a few clerical errors, such as the corner lots were included in the bylaw twice and one property was included that was being assessed for the curb, gutter and sidewalk for a different project.

Administration corrected the errors, recalculated and redrafted the Schedule A to reflect the above mentioned subdivision, actual costs of the project, and the clerical errors made in 2007 at the bylaw preparation time. For comparative purposes:



The estimated cost for this project at the bylaw preparation time was \$176,440.00 with the benefiting owners' share of \$52,932.

The actual costs of installing curb, gutter and sidewalk on this project was \$201,334.92. This has increased the benefiting owners' cost to \$60,400.48.

MAY 03 2011 An accountability session on effective delivery of the Agricultural Operation Practices Act (AOPA) was held September 27, 2010 in Edmonton. Ministers Mel Knight, Sustainable Resource Development (SRD) and Jack Hayden, Agriculture and Rural Development (ARD), attended the session, which was chaired by deputy ministers Eric McGhan (SRD) and John Knappi(ARD). Successes included the NRCB's emphasis on using science-based evaluations at confined feeding operations to assess environmental risk levels and determine groundwater monitoring requirements. Members also commended the strong working relationships and policy development achieved through PAG, and the accessibility of the NRCB to stakeholders. Opportunities identified by PAG members included aspects of the legislation that would benefit from greater clarity (for example, grandfathering), increased transparency for AOPA standards and approval requirements, and additional consultation with municipalities on permit amendments. The report from the accountability session is available on the NRCB website.

#### Board reviews under the Agricultural Operation Practices Act

Natural Resources Conservation Board

In 2010, the NRCB board reviewed and amended one approval officer decision. The board upheld the Hutterian Brethren of Three Hills' request to use a natural cover for its earthen manure storage instead of a synthetic cover. It imposed conditions requiring a straw cover, minimum thickness, regular testing and reporting. The board also granted a review of an enforcement order, which is pending at the request of the operator.

To date, the board has reviewed two decisions in 2011:

- · An approval granted to Grow North Inc. to construct a proposed confined feeding operation close to High Level, consisting of four feedlot barns to collectively house 5000 beef finishers. The hearing was held in High Level on March 1. The board determined that the application was inconsistent with the land use provisions in the municipal development plan. It also concluded that, in this instance, it would not be appropriate for the board to use its authority to override the provisions restricting CFO development. The board overturned the approval and released its decision on April 11.
- An AOPA permit allowing Zealand Farms to construct a new 95,000 poultry broiler operation in Ponoka County. The board hearing was held March 23 in Ponoka. The decision report will be released within four to six weeks.

#### Policy Advisory Group update

The Policy Advisory Group (PAG) met September 27, 2010 in conjunction with the accountability session, and on February 2, 2011. Over the past year, PAG has provided valuable input to discussions on the NRCB's leak detection program and the new policy on amending municipal permits. Future discussions will address issues such as nutrient management under AOPA. cumulative effects and the judicial review process.

PAG members are appointed by each livestock sector, municipal and environmental non-government organizations, Alberta Environment, Agriculture and Rural Development, and the NRCB. A current list of members and the PAG terms of reference are available on the NRCB website. The next PAG meeting will be held October 4, 2011.

# Leak detection program (LDP) and permit amendments

The leak detection project ended in 2010. Nearly 80 per cent of the 257 operations were ranked low risk. A low risk rating indicates that the groundwater is protected by either or both the facility construction and natural features of the site. The NRCB was able to suspend the monitoring requirements for the low risk facilities. Of the remainder, only four per cent were ranked high risk. Moderate and high risk facilities must continue to be monitored. In a few cases, monitoring has been increased.

The NRCB is amending the permits in consultation with the operators and municipalities that originally issued the permits. Monitoring conditions will remain in the permits, but will be amended for future flexibility and to accurately reflect site risks. Operators who would like the conditions removed from their permit must formally apply for the amendment. This process requires public notification. The NRCB expects to complete all permit amendments by fall 2011.

#### Seasonal reminders

- Application timelines for 2011 construction—Please submit your application to the NRCB as soon as possible for construction in 2011. For help preparing your application, please contact an ARD extension specialist. For information about AOPA requirements, contact the NRCB field office nearest you.
- Surface water protection—Operators are reminded to prevent surface water contamination from manure run off caused by snow melt and spring rain. If you have any questions, please contact the nearest NRCB field office for information.

### Risk based compliance program underway

The NRCB's risk based compliance program was implemented in 2010. The updated compliance and enforcement policy includes the risk based compliance program and became effective in spring 2010. Information about the program and policy are available on the NRCB website or by contacting an NRCB field office.

The program uses three criteria to identify confined feeding operations that may pose a risk to groundwater: use of an earthen manure storage facility (these facilities pose more risk than other storage facilities); construction of the facility before 2002 (construction may not meet AOPA standards, or the construction standard may be unknown); and location in a region identified by Alberta Environment maps as having high groundwater vulnerability. Operations that meet all three criteria are being contacted by the NRCB to set up a risk screening. To date, the NRCB has screened 16 of 172 operations under the program. NRCB staff are reviewing the results and will be working with operators to address any follow up issues.

# New requirement for groundwater well sampling by independent third party consultants

On a go-forward basis, groundwater monitoring well sampling is to be conducted by a qualified, independent third party contractor. For more information, contact your nearest NRCB field office or Andy Cumming, Director, Field Services at 403-381-5166 (dial 310-0000 for toll free).

#### Technical guideline now available

The new technical guideline Reclamation of Groundwater Monitoring Wells is now available and will be of interest to operators and consultants. The guideline is available from any NRCB field office or ARD extension office, and is posted on the NRCB website.

Guidelines under development include:

- monitoring well construction
- · confined feeding operation closure
- · concrete, and
- geotechnical assessment of earthen liners and protective layers.

### Vacant approval officer position filled

The NRCB is pleased to announce that Kari Lisowski will join the Red Deer office as an approval officer, effective April 19th, filling the vacancy created by Sandi Robert's retirement. 


## Alberta Forest Week — May 2 - 8, 2011






#### **Arboretum Renewal**


