- 1. This permit approval is subject to approval from the Alberta Motor Vehicle Industry Council (AMVIC).

 The developer is required to obtain written approval from the Alberta Motor Vehicle Industry Council regarding the proposed development prior to commencement of the development. Failure to do so shall render this permit Null and Void.
- All conditions and requirements by the Alberta Motor Vehicle Industry Council "AMVIC" are to be met to their specifications and standards.
- 3. This permit may be revoked at any time if, in the opinion of the Development Authority, the proposed development has become detrimental or otherwise incompatible with the amenities of the neighborhood.
- 4. The **Building/Shop** used for the Automotive Equipment and Vehicle Services Business shall meet all Alberta Safety Code requirements and any other requirements specified by Superior Safety Codes. Failure to do so shall render this permit Null and Void.
- 5. Provide adequate off road parking as follows: The minimum parking standards are one space per each full time employee. (One parking space, including the driveway area, shall occupy 27.87 square meters (300)

- square feet)."
- 6. This permit approval is subject to the access to the property being constructed to County standards. PRIOR to installation of a new access or changing location of existing access, complete a Request for Access form by contacting the Operational Services Department for Mackenzie County at 780-928-3983. Access to be constructed at the developers' expense.
- 7. The sign shall be located a minimum of:
 i. 200 meters (656 feet) from regulatory signs.
 ii. 3.1 (10 feet) from the outer edge of the road or not less than 1.5m (5 feet) from the property line.
 iii. 1.5 meters (5 feet) to a maximum of 2.5 meters (8 feet) in height above the shoulder of the road.
- The site and sign shall be kept in a safe, clean, and tidy condition, or may be required to be renovated or removed.
- 9. The sign shall:
 - a. Not obstruct the orderly and safe flow of vehicular and pedestrian traffic,
 - b. Not unduly interfere with the amenities of the district,
 - c. Not materially interfere with or affect the use, enjoyment or value of neighbouring properties, and
 - d. Not create visual or aesthetic blight.
- 10. Illumination of the sign must not negatively affect, nor pose a safety hazard to, an adjacent site or street.
- 11. Wiring and conduits of the sign must be concealed from view.
- 12. The total site area (lot) shall have a positive surface drainage without adversely affecting the neighbouring properties.
- 13. No construction or development is allowed on a rightof-way. It is the responsibility of the developer/owner/occupant to investigate the utility rights-of-way, if any, that exist on the property prior to commencement of any construction and to ensure that no construction or development is completed on any utility right-of-way.
- 14. The Developer shall at all times comply with all applicable Federal, Provincial and Municipal legislation and regulations and County Bylaws and resolutions relating to the development of the lands.

Mackenzie County

Monthly CAO Report to Council – May 2013

The County's summer programs and the 2013 construction season have officially started. Summer employees have been hired to assist in various maintenance programs.

This report provides highlights on some completed or ongoing initiatives.

- 1. **AB Agriculture and Rural Development** we received a letter from the Ministry confirming up to \$50,000 funding towards the drainage plan. RFP will be advertised shortly. Two ASB members and Grant Smith, Agricultural Fieldman have flown over the areas of flood in early May and the collected info will be communicated to the selected engineering firm.
- 2. **Fort Vermilion Research Farm** Council discussed the offer to purchase at their last meeting and administration is proceeding as directed.
- 3. AB Transportation Mackenzie County's resource applications for Highway 88 Connector and Zama Access road were denied. A letter was sent to the Premier of Alberta requesting a meeting to discuss critical transportation infrastructure for our Region. Council has provided direction to administration regarding these two projects at their last meeting. Administration is working with the engineering firm on tendering Phases II and III of the Highway 88 Connector. Administration is looking into dust control options for Zama road prices are being obtained.
- 4. Strategic Priorities Report Administration is working on the priorities as identified.
- 5. **Regional Collaboration** Council reviewed the draft RFP for the Regional Sustainability Study at their last council meeting. The Committee is meeting on June 7 & 8 to review the final draft, a draft communication protocol and a draft news release.
- 6. *Housing Boards Amalgamation* this is an ongoing work with the Implementation Committee. An update will be provided to Council in-camera.
- 7. *Mustus Energy Ltd.* the Option to Purchase was negotiated as directed by Council and signed by both parties.
- 8. **Regional Water System** a letter was sent to the Town of High Level inquiring regarding their interest in a regional water system project with the County.
- 9. **RCMP** a new agreement was signed with RCMP for the La Crete office lease space and MOU for La Crete enhanced police (one position) was signed. Zama office space lease calculation was prepared and submitted to the HL Detachment waiting for their response.
- 10. *Regional Service Sharing Agreement with the Town of High Level* preparing a reply letter based on the Town's response and Council's direction. This will be presented and discussed in camera.

11. *Disaster Recovery Program* – an application was submitted to Alberta Emergency Management for the overland floods resulting from high accumulation of snow and rapidly rising temperatures in early May. As communicated earlier, it may take up to six months for AEMA to make a decision on the County's claim. The County's public works employees continue the roads repair work.

This report is a brief overview of projects and activities for Director of Infrastructure Development & Government Relations, Director of Community Services and Operations North and some Agriculture department items.

A) Public Works General

Dust control is basically complete for now there will be one more application scheduled for later in June for area's missed or special requests. (Motion 13-04-276)

Grass cutting and general maintenance is underway. ASB has a separate plan for roadside brushing.

The Fort Vermilion Walking Trail project is underway and we are collaborating with local groups and the Board of Trade.

The tender for 53rd street paving has been awarded to Knelsen Sand & Gravel subject to local improvement bylaws being complete.

Crack sealing & line painting is in the works, completion is estimated for September 2013.

The investigation into gravel base/seal coat projects need your direction and budget allocation if we are to proceed. We intend to have clear estimates for the June 26th meeting with comparisons to cold mix (in place).

Gravel for future development is in the council package.

B) Land Use Framework

E) Zama & Highway 88 Connector

In regards to the Primary Highway designation of Zama & 88 Connector I suggest that the CAO & Reeve request an urgent meeting with the Minister of Transportation to discuss the matter.

F) Fort Vermilion Research Facility

The negotiations with Agriculture Canada for the Fort Vermilion Research Facilities are being reviewed for the land & equipment acquisitions. This matter needs your immediate attention and direction.

G) Water

Water matters are under study ie. - Rural Water Supply for High Level South & North, ground water inventory across the County and overall regional water. You or Council giving a clear directive would really assist us in the project development.

H) Parks

Parks development is being reviewed (ie. – Jubilee Park, Bridge Campground & Tompkins Landing etc.).

I) Base & Paving

The base & paving of Phase I of Highway 88 Connector & Phase II of Zama Access are underway and should both be complete by the end of June 2013.

J) Highway 88 Connector

The next phase of Highway 88 Connector is being tendered and the intent was to close the tender on June 26, 2013 Council meeting with the construction completion date of August 2014?

Re: Fort Vermilion Area Park Playground

The current state of the playground at the Fort Vermilion Arena Park is in need of attention. Not only is the old playground equipment at this location an eyesore for the community, but it also presents a safety hazard for our young people.

The play space at the Fort Vermilion Arena Park was inspected by Environmental Health first in 2007 and again in 2008. A copy of each report is attached to this letter. The issues that were identified with the space are as follows:

Swings:

- Too many swings in one swing bay (recommendation is that only two swings be in one bay).
- The connecting device for the swings has a gap that is greater than the recommended 1mm.
- Protective surrounding surface has become inadequate for absorbing shock.
- Metal is rusted and corroded.

Monkey Bars:

- Protective surrounding surface has become inadequate for absorbing shock.
- Metal is rusted and corroded.

See-saws:

- Inadequate spacing between the see-saws (minimum requirement is 1.2 m)
- Protective surrounding surface has become inadequate for absorbing shock.
- Metal is rusted and corroded.

The current Environmental Public Health Inspector with Alberta Health Services has indicated that these issues are still relevant. He also supplied a copy of the Alberta Health Services' Playground Guidelines that must be followed for playground safety. It is the responsibility of the land owner to ensure these standards are followed for safety and insurance purposes.

The Recreation Board is committed to seeing this space become revitalized, as it represents a great opportunity to modernize the equipment and create a space for our youth to enjoy. However, this is not a project that we have the funds for. We are writing to you, Reeve and Council, to bring this important issue to your attention.

- 3. Non-Encroachment Zone- a shrub is growing in the non-encroachment zone in the La Crete Playground located behind the MD Office.
- 4. Distance between Seesaws is not greater than the required 1.2 m (Playspace in Fort Vermilion
- 5. Surface Material is deteriorating and rusted. (Playspace in Fort Vermillion- seesaws, swings, monkey bars)
- 6. Swing Fastening Devices are unacceptable as the fastening device has an opening > Imm and the metal is corroding. (Play space in Fort Vermilion)

Pertaining to the full pressure/flow line running west of La Crete administration is seeking direction on connection procedures, we are proposing that all connections outside the Hamlet boundaries be deemed rural connections and therefore will require a meter pit with flow restrictors at the property line, and that all current connections be grandfathered in at their current status.

Rural water as referred to in Bylaw 849-12 provides the following definitions and the procedures in section 4.

BYLAW NO. 849-12

IN THE PROVINCE OF ALBERTA RESPECTING THE WATER AND SEWER SYSTEM

- a) "Rural Waterline" a municipal potable waterline operated as a trickle system, which is not part of any Hamlet's distribution system.
- b) "Rural Water User" means any Consumer, located outside of Hamlet boundaries, that is connected to the Rural Waterline.
- c) "Trickle System" means a water distribution system with reduced pressure and flow.

4.1. RURAL WATERLINE CONNECTIONS

- 4.1.1. A Registered Owner requesting a water service from the Rural Waterline shall apply for Municipal Utility services. If the application is approved by the County, the County shall provide the water service to the property line.
- 4.1.2. Where water service has been brought to the property line of a vacant parcel of land, the developer and/or Registered Owner of the property is required to connect to the water service and pay for the costs of the same upon the construction and/or placement of any dwelling or occupied building on the lands.
- 4.1.3. The Consumer shall pay a fee as set out in the Fee Schedule bylaw for the connection to the Rural Waterline.
- 4.1.4. The County shall sell and deliver water to the Consumer, so far as is practical to do so at the service location indicated in the Utility Connections policy. The County will install and operate the Rural Water Line as a Trickle System at a maximum rate of 1 gallon per minute for residential users and 2 gallons per minute for Commercial users, unless otherwise approved in writing by the CAO.
- 4.1.5. Title of water supplied by the County shall pass from the County to the Consumer at the outlet of the meter lift.

- 4.1.6. The Consumer shall not add or sell water to other structures, including houses, trailers, or businesses that are not directly owned by him, exist on the serviced yard and/or are further than 200 meters from the primary dwelling, unless approved in writing by the CAO or Designate. The County reserves the right to discontinue service to the primary service location on the decision of the County that a service violation has been installed.
- 4.1.7. In the event that the Consumer subdivides the parcel of land to which water is supplied hereunder, the water service shall apply to that portion of the subdivided land upon which the Point of Delivery is located.
 - a) Water service shall only be available to the other subdivided parcel or parcels pursuant to a new application being submitted and subsequently being approved by the County.
- 4.1.8. The Consumer must construct, at His own sole cost and expense, a holding tank for reserve purposes that will be suitable and adequate for His anticipated water requirements. Anticipated water requirement shall be calculated as specified within Mackenzie County's Engineering Guidelines and/or General Municipal Improvement Standards



Title: Bylaw 880-12 Road Closure lying between SE 1-104-18-W5M

and NE 36-103-18-W5M (Blue Hills)

BACKGROUND / PROPOSAL:

Bylaw 880-12, being a Road Closure Bylaw for the closure of a portion of statutory road allowance lying between SE 1-104-18-W5M and NE 36-103-18-W5M for the purpose of sale and consolidation with the adjacent lands, received first reading at the November 28, 2012 Council meeting.

All road closure Bylaws must receive a Public Hearing prior to being sent to Alberta Transportation for approval. On February 12, 2013 a Public Hearing was held and all information was sent to Alberta Transportation on February 28, 2013. On May 29, 2013 Mackenzie County received back the Approved and signed bylaw from Alberta Transportation.

History/Background

The Blue Hills Community School located on SE 1-104-18-W5M constructed a skating rink and sewage lagoon back in 1988. Part of both developments are situated right on the subject road allowance, they also planted trees down the centre of the road allowance. A request to close this road allowance was made several years ago in 2002 where Council reviewed it at the November 5th, 2002 meeting. Council's decision was to refuse the request due to potential future need for the road allowance. Closing this portion of road allowance could present access problems in the future, as there is a low-lying section to the west of this road allowance where road construction may not be an option (see attached aerial photo).

Fort Vermilion School Division is requesting this closure as they feel that at the time they followed all the regulations. The applicant claim that during development, the bylaw showed a 20-meter road allowance. However, when they proceeded to the planning

stage it changed to 30 meters. The surveyors were under the impression that the road allowance was still 20 meters and situated the lagoon and rink accordingly.

The transition from 66 feet (20 meters) to 99 feet (30 meters) road allowance width transgressed between Range 17 to Range 18 and Township 104 to 103. This was most likely the reason behind the misunderstanding.

However, even if the road allowance had only been 66 feet (20 meters) the skating rink would still be encroaching. Development Permit 135-DP-88 issued November 30, 1988 clearly states that the setbacks are, 134 feet from front yard, 50 feet rear yard and 50 feet side yard. The aerial photo attached shows how the rink encroaches over the road allowance.

Due to the road allowance transition from (20 meters) to 99 feet (30 meters) being adjacent to each other with this quarter, the Road's Department recommends to close only the north half or 10 meters of the road allowance thus evening it out with the road allowance on the east end. Only that half or 10 meters would be sold to the School Division to consolidate into their subdivision. Although this would not bring the Skating rink and the sewage Lagoon into compliance with the Land Use Bylaw, it would place the structures within the School property.

The Planning Department has no issues or concerns with the closure of only a portion of this road allowance.

The application was presented to the Municipal Planning Commission (MPC) at their November 1, 2012 meeting where the following motion was made:

That the Municipal Planning Commission recommendation to Council be for the approval of Bylaw ____-12, being a Road Closure Bylaw for the closure and sale of the most northerly 10 meters of Government Road Allowance lying south of SE 1-104-18-W5M, subject to public hearing input.

Bylaw number 880-12 has since been assigned to this application.





Thank you for the opportunity to review the proposed Industrial Area Structure Plans within the IDP area.

In regards to the proposed Mackenzie Highway Plan the Town does not have any comments as the proposed industrial nature of the plan follows the direction and intent of the Inter-Municipal Development Plan.

Upon review of the Footner Industrial Area Structure Plan I've noted that it does not conform to the Industrial Development Section of the Inter-Municipal Development Plan. The IDP states:

The Town's industrial area is located in the southern portion of the municipality and the major industry in the County is located south of Town. In consideration of this, the higher density residential development and the airport to the north, both municipalities will refer industrial development south of the Highway 58.

Not only is the creation of an industrial area structure plan in this area contradictory to the above section it's also contradictory to Schedule F. Schedule F shows a Highway Commercial corridor paralleling Highway 58 from High Level all the way north to the end of the IDP boundary. The draft plan does not mention that the proposed area is within the Inter-Municipal Development Plan area, the only place it's mentioned is a sentence in Section 4.1 stating that all applications for subdivision and development should follow the processes outlined in the IMDP.

Due to these inconsistencies and the potential future impact the proposed plans may have Administration felt it appropriate to forward them to Council for comment. Council reviewed both proposed ASP documents at the regular Council meeting on May 27th and passed the following resolution:

The Honourable Greg Weadick, Associate Minister for Municipal Affairs, is leading a consultation process to identify the issues that municipalities may face as Alberta Health Services moves to consolidate emergency medical services (EMS) dispatch. The consultation will also offer municipalities a chance to raise potential issues regarding medical first responder services often associated with municipal fire departments. These sessions are intended as follow-up and confirmation of input from our initial meetings with the Alberta Urban Municipalities Association, Alberta Association of Municipal Districts and Counties, and the Alberta Fire Chiefs Association and the on-line consultation currently underway.

The consultation session are scheduled to occur over the next few weeks. All municipalities are welcome to participate. A discussion paper, which has already been distributed, is reattached in this email.

If you wish to attend a session, you must RSVP to Lesley MacAllister at lesley.macallister@gov.ab.ca and provide your name, the municipality you represent and the session you wish to attend. Space is limited so only attendees who have RSVP'd will be planned for—limit of two participants per municipality. Make sure to take note of the RSVP deadline for each session.

Impacts of Emergency Medical Service Dispatch Consolidation Consultation

Discussion Paper



In March 2013, the Alberta Health Quality Council released a report recommending changes that would improve ground ambulance services. Alberta Health accepted their recommendations. Among the recommendations was that emergency medical services (EMS) dispatch should be consolidated to improve information gathering and the efficiency of ground ambulances. Recognizing that EMS dispatch consolidation could impact municipalities, it was determined that a transition plan was needed.

The Honourable Greg Weadick, Associate Minister of Municipal Affairs, is leading a consultation to identify issues municipalities and their fire services may face as a result of the EMS dispatch consolidation and identify pressures around municipal medical first response services. This consultation will not revisit Alberta Health's decision to accept the recommendations of the Alberta Health Quality Council regarding EMS dispatch consolidation.

This consultation supports recommendations from Alberta Health Quality Council's report by gathering information from municipalities to assist the development of transition planning for communities affected by EMS dispatch consolidation. Through development of this transition plan, government intends that Albertans will continue to receive quality municipal emergency services (911 call centres, local dispatches and fire services) as EMS dispatch consolidation continues.

To initiate the process, the Associate Minister held meetings with the Alberta Urban Municipalities Association (AUMA), the Alberta Association of Municipal Districts and Counties (AAMDC) and the Alberta Fire Chiefs Association. Those discussions began to scope out the key issues and concerns and form the basis of this discussion paper.

This paper is meant to guide discussion at the stakeholder meetings scheduled for May 2013. The paper briefly outlines the issues brought forward by municipalities and their fire services, identifies what the Associate Minister heard in his discussions with the AUMA, the AAMDC and the Alberta Fire Chiefs Association, and suggests some potential solutions that government and municipalities could implement to address those concerns.

The key themes heard in the meetings were:

- 1. Training and workload for the fire service providing medical first response
- 2. Technology, communications and information management
- 3. 911 viability
- 4. The need for stakeholder engagement by Alberta Health Services and by government

As you read this paper and prepare for the upcoming meetings, you are encouraged to consider potential financial implications to your organization related to dispatch consolidation and the provision of first response services, and share them with Associate Minister Weadick at the consultation or through the online consultation. An invite to the online consultation will be sent to all municipalities in May 2013.

1. Training and workload for the fire service providing medical first response

Medical first response is a service that provides initial first aid treatment to an injured person prior to the arrival of emergency medical services. It is often provided by municipal fire departments as part of the municipality's first response. In certain medical conditions this can allow for better patient outcomes, as a patient can begin to receive medical treatment as soon as possible.

In discussions with municipal and fire service representatives, there seemed to be a perception that EMS dispatch consolidation could lead to an offloading of responsibility for medical services from EMS to fire services through medical first response, or that there is an expectation that municipalities are in fact responsible for providing medical first response to its citizens.

In the view of Alberta Health and Alberta Municipal Affairs, the provision of medical first response is a municipality's choice, and should be determined based on the municipality's assessment of the risks and benefits of such service.

Municipalities may choose to discontinue providing the service. For example, the City of Lacombe no longer dispatches fire service to medical first response calls, and has worked with Alberta Health Services to ensure that the citizens of Lacombe continue to receive appropriate EMS services.

Municipalities may choose to continue the provision of medical first response through the fire service. In discussions with municipalities and their fire service, we heard that the provision of medical first response by a fire service helps foster a healthier fire service and ensures patients receive care quickly. The opportunity for volunteer fire fighters to receive medical first response training can be a positive factor in the recruitment and retention of volunteers, as the training offers a more diverse experience and skill set to volunteers and more ways to serve their community. Medical first response also provides an initial response if an ambulance is delayed.

It should be noted that Alberta Health Services has developed seven medical first response working groups that will provide content in order to establish a framework support and guide the linkage between medical first response services and EMS. The framework will address the following issues: medical oversight, medical control protocols, quality assurance, patient call reports, training and skills, dispatch roles and events, and a medical first response registry.

What We've Heard So Far

In Associate Minister Weadick's meetings with the AUMA, the AAMDC and the Alberta Fire Chiefs Association, we heard the following:

- Concern that medical services are being offloaded onto municipalities through medical first response.
- Municipalities that do offer medical first response services often bear significant costs, including training and the provision of equipment and consumables.
- There is a need to recognize the strain on fire service personnel, especially those providing medical first response.
- Rural municipalities feel recruiting volunteers to the fire service greatly hinders their ability to provide medical first response and that adding more training does not adequately address that need.
- Alberta Health Services doesn't fully recognize how capable some medical first response services are in some communities.
- Medical first response training is a large commitment (200-400 hours).
- Volunteers would be willing to assist with patient transport to the hospital, but often cannot get home if they do so.
- Some communities have established medical first response-only volunteers and with some support, this could improve services.
- Wait times in emergency rooms are putting pressure on municipalities to provide medical first response, and that more ambulances could be active in communities if wait times were addressed.

Potential Solutions We've Heard

- Providing support to municipalities for medical first response training and for equipment and consumables used in delivering medical first response.
- Developing a more robust municipal medical first response-only volunteer base (a civilian medic concept).

2. Technology, Communications and Information Management

Communication was generally viewed as something that needs to be addressed in two areas – between EMS and fire dispatches, and between services at emergency events.

When government launched this consultation, the primary concern was to ensure that dispatch-to-dispatch communications and inter-service on-scene communications would operate smoothly. While some concerns were raised by the Alberta Fire Chiefs Association, government is uncertain if the full scope of the potential issue is known by stakeholders.

Problems could occur when a 911 call is received and emergency services are dispatched as a result of EMS dispatch consolidation. Operationally, a 911call centre worker may need to transcribe information multiple times for a single call for multiple dispatches. This could lead to errors, as there is not a common operating platform for all dispatches. For example, due to an address input error, a fire service could respond to the wrong address.

Government is aware that challenges exist with multiple public safety answering point centres and multiple fire, police and EMS dispatch centres. There is not one common operating platform for all dispatch centres, which results in the requirement for information to be relayed between centres.

Communication between services at events is an issue that Alberta Justice and Solicitor General is working to address through the Alberta First Responder Radio Communications System, slated to be online in some areas of the province later this year. The system creates an open source standard for two-way radio communications allowing emergency services to all be on the same radio network and to not be as restricted in the types of devices that work on the network.

While it is a municipal choice to use this new system, our discussions with the AUMA, the AAMDC and the Alberta Fire Chiefs Association indicated strong support for it. This positive view of the new system and a general consensus that an effective radio communications system that offers interoperability and agency cohesion may indicate that adopting a communications standard could be a positive move in developing more synergy in Alberta's public safety system.

One reason the Alberta First Responder Radio Communications System could become a standard is that government has worked to lower the price of radio systems by being a central purchaser of radios. It was previously thought that radios may be too expensive, but there seemed to be a consensus that the new system is affordable. It may also improve communications between emergency services and dispatches, as dispatches could use it for its radio communications.

The Alberta First Responder Radio Communications System is expected to be completed in 2014. A downside is that municipalities that move to the new system will need to run two radio communications; one for emergency personnel and another for regular municipal business (transportation, parks, water, etc).

What We've Heard So Far

- Concern from the fire chiefs that 911 centres needing to transcribe on two different systems for an EMS and fire service response call could result in a higher likelihood of errors.
- The Alberta First Responder Radio Communications System is a good initiative that will improve the public safety system and municipalities are looking forward to its launch.
- Concerns that on-scene communications may add difficulty for fire services needing to know how long it will take EMS to arrive.
- Must ensure information sharing is possible during an emergency event.
- Dispatch centres not respecting the boundaries of a fire service, or even knowing the boundaries.
- Concerns that EMS dispatch consolidation may not respect local knowledge.
- Understanding that EMS dispatch consolidation decision is about better patient outcomes and should provide more appropriate service as data is collected and analyzed.
- Both the AAMDC and Alberta E911 Advisory Association, which represents 911 call centres, also pointed out that dispatching is a challenge in rural areas and First Nations communities because addresses are inconsistent or nonexistent.

Potential Solutions We've Heard

- Develop or support a common operating platform for dispatches (EMS and fire) to ensure communication and information sharing is timely and accurate. Fire Chiefs and 911 Call Centres have suggested an interface between computer-aided dispatch systems.
- Utilize the regional collaboration grants to support regional solutions to dispatch.

- As part of the fire service policy framework, consider standards for communication.
- Advancements in GPS and mapping technologies may resolve some of the challenges. There also needs to be a "single source of truth" for Geographic Information System.

3. 911 Viability

Many public safety answering points in Alberta provide both 911 call answering services and other dispatch services, particularly in non-urban areas. As EMS dispatch is consolidated to Alberta Health Services, the Public Safety Answering Points impacted by this change will experience a drop in dispatch volume.

Several smaller public safety answering points that rely on revenue generated by providing EMS dispatch may face financial difficulties in the coming years. The *Emergency 911 Act*, passed in early May 2013, will provide public safety answering points with an additional source of funding through a 911 levy on wireless cell phone subscribers. However, it is not anticipated that this money will replace the lost revenue from EMS dispatch consolidation.

What We've Heard So Far

- Some public safety answering points have indicated that the majority of their workload comes from EMS dispatching.
- One public safety answering point estimated that EMS dispatch volumes accounted for as much as 90 per cent of their total call volume.
- The Alberta Fire Chiefs Association indicated that a high percentage of calls transferred to fire services from public safety answering points are for medical first response, especially in rural areas.

•

- Many public safety answering point centres do not dispatch police services, as those call are transferred to the RCMP or to the local municipal police service. This will result in some centres only providing 911 call answering and fire services dispatching.
- Some public safety answering points have made cutbacks and reduced staffing in response to the decrease in dispatch volumes and loss of funding associated with EMS dispatching.
- One public safety answering point has expressed concerns about their long-term viability, as EMS dispatch funding was a significant part of their revenue.

Potential Solution We've Heard

 Utilize regional collaboration grants to find regional solutions to 911 and fire dispatch. 	

4. Stakeholder Engagement

The need for improved stakeholder engagement was a consistent theme throughout our meetings. Keeping stakeholders informed, allowing them to provide input, and explaining why decisions are made are the hallmarks of good public policy development and implementation. It ensures that concerns can be addressed and that opportunities can be identified because in the end, we all want to do what is best for Albertans.

The following feedback from the AUMA, the AAMDC, and the Alberta Fire Chiefs Association reflects points made about government and Alberta Health Services.

What We've Heard So Far

- Provide clearer information about why EMS dispatch consolidation was chosen and its potential benefits to Albertans and municipalities.
- Stakeholders want to be engaged in the framework development of medical first response.
- It was positive to see all three ministries involved in the impact of EMS dispatch consolidation at the table to listen to stakeholders.
- Would like to see more positive interactions with Alberta Health Services, or more evidence that Alberta Health Services is listening to stakeholders.
- Government should provide more information to municipal associations so it can be communicated to their members.

Potential Solutions We've Heard

- More engagement between Alberta Health Services with the medical first response working groups.
- Continue to maintain the three ministry team for this project to oversee the transition plan of EMS consolidation.
- Improve communication with the AUMA, the AAMDC and the Alberta Fire Chiefs Association as the transition plan is implemented.
- Encourage Alberta Health Services to be more involved in major emergency event post-mortems.





Re: Air Ambulance Service – Peace River

Honorable Minister, the Town of Peace would like to formally express our concern with the most recent decision by Alberta Health Services to remove an air ambulance plane from Peace River. This initiative was undertaken without any prior involvement or discussion with our Council or, to our knowledge, any of the other municipal representatives or health care professionals in our region.

We have received the FAQ bulletin but are not satisfied with the information contained in that correspondence. It appears the document is intended to justify the decision that has been made but, in our opinion, the rationale is less than convincing.

We believe that Peace River is centrally located to serve the entire region and the simple fact that the Peace River air ambulance was able to respond to such a large number of calls from other communities should be viewed as a positive attribute of the existing service. However, the FAQ uses this point as an underpinning to their rationale that the service needs to be partially relocated. Interestingly, the FAQ bulletin subsequently states that planes are not meant to serve one community. Specifically, we quote the following:

"How will we have a better quality of care, if we only have one plane based here?

It is important to remember while a plane is based in a particular community; it is not solely for the use of residents of that community."

In our opinion, this is a contradiction in that Peace River based aircraft are ideally and strategically located to serve the many communities of northwest Alberta (we were previously advised that the Peace River base has the highest number of calls of any air ambulance service); however, because of being able to provide this excellent regional service, the number of local flights when compared on a percentage basis, is only 20% of the total flight volume. In other words, we seem to now be the victim of having a service that met, and apparently exceeded, the mandate of "not solely for the use of residents of that community".

Unfortunately, when we attempted to contact the current service provider to get their opinion on the impacts of this change we were advised that they were "prohibited" from speaking with us due to the requirements of the RFP under section 2.5. Clearly, we have great difficulty accepting that a potential bidder is prevented from speaking at will about an RFP released by a provincial government body. This blatant attempt to hide from public scrutiny should be immediately retracted.

Honorable Minister, the Town of Peace River recognizes and appreciates the difficulties associated with providing health services to the residents of Alberta and we understand that rationalizing air ambulance is also a challenging endeavour and that we are by no means the experts. Unfortunately, we also feel that decisions are being made that affect the health, well being, and viability of our Town and region without discussion, adequate explanation, or full consideration of the impacts. We therefore respectfully request that the RFP be temporarily held in abeyance until such time as the affected parties are properly consulted with.







Deh Cho Travel Connection

What is the Deh Cho Travel Connection?

A travel destination!

The Deh Cho Travel Connection (route) is the scenic travel route that links the Mackenzie, Liard and Alaska Highways that cross northern Alberta, northern British Columbia and the Northwest Territories.

A collaborative marketing coalition!

The Deh Cho Travel Connection is a coalition of communities, municipal and regional tourism organizations and agencies that are working together to market the Deh Cho Travel Connection route as a tourism destination.

The success of the Deh Cho Travel Connection is attributable to the commitment and expertise of this diverse working group who vigorously market the lure of our unique northern wildlife, nature, culture, heritage and hospitality as a drivable wilderness adventure experience.

What does the Deh Cho Travel Connection market?

A travel adventure!

The Deh Cho Travel Connection does not promote any specific products or adventures. It does however, focus on drawing tourists to your community where local visitor centre staff and tourism operators can encourage these guests to visit your local attractions, partake in local activities, embrace your community's lifestyle and experience your local hospitality, which will convince tourists to stay in your community longer.

A driving wilderness adventure. The Deh Cho Travel Connection promotes the route and region as a tourism destination to a variety of tourists who are seeking a drivable vacation experience.

A menu of "side-trips" and adventures off the beaten path. The Deh Cho Travel Connection also encourages tourists to visit communities that are not directly on the route, or to hike, canoe or try out other activities that take them off the beaten path.

Recreational, nature-based, historical and cultural tourism adventures. The Deh Cho Travel Connection provides communities an excellent medium to promote a range of recreational, nature-based, cultural and heritage activities.

Who does the Deh Cho Travel Connection market to?

The explorer!

The Deh Cho Travel Connection's primary market is the touring nature-lover explorer. Someone who wants to get "side-tracked", who is independent, has freedom in their schedule, and has an inclination to explore. They may be on their way to the Yukon or Alaska or just heading north to discover the unexplored wilderness. They may have a weekend adventure planned out or are just wandering with the camera ready for that spectacular photo-op. They may be on their way to visit an old friend or just looking for a wholesome family festival.

The one thing they likely have in common is that they are driving. It might be a 40' RV or a 5th wheel camper, it might be the family car or van, a pick-up truck or SUV, it might even be a bicycle or a motorcycle. Another thing they have in common is they are looking for something new.

A Brief History

Deh Cho Travel Connection

The first organized meeting of the Deh Cho Travel Connection was held back in 1991 between individuals from Hay River, NT and High Level, AB who wanted to investigate the possibility of marketing a circle-drive or loop through their regions.

The Mackenzie Highway was a well established travel route in northwestern Alberta and the southern Northwest Territories. It also became apparent that the Liard Highway could be a natural "connection" to the Alaska Highway in northeastern British Columbia, completing an adventurous travel loop.

At that time, the tourism sector in northern Alberta was still maturing, while in northeastern British Columbia traffic for the Alaska Highway was strong, they were both looking for new angles to promote their areas. They also recognized that any increased traffic heading to the Northwest Territories resulted in flow-through traffic for their regions.

The marketing of this new loop would provide an interesting challenge as it traversed three unconnected market regions. It was apparent that a unique marketing coalition would be needed to promote the route. The group also recognized the simple fact that many of the traditional contributing funders were already tied to their own local and regional tourism marketing campaigns.

A partnership was established with the governing principles that wherever practical, the use of partner's staff would be used and accessible funds would be pooled. Those funds would be devoted solely to market and promote the route on behalf of all partners.

Over the many years, the core structure and purpose of the coalition remain unchanged.

Organizational Overview

Purpose:

To raise the awareness of and to actively promote the Deh Cho Travel Connection route as a viable and realistic northern tourism and adventure opportunity.

Structure:

The Deh Cho Travel Connection team consists of a fluid alliance of community and regional stakeholders who are typically involved in tourism or economic development activities throughout the loop. Team members are expected to volunteer to participate for specific tasks or projects and it is assumed that they would complete these as part of their regular duties. In the interest of focusing all resources into marketing and promotion, the Deh Cho Travel Connection has not become an incorporated society. The group has been comfortable with this structure as all financial and administrative functions are being performed within the bounds of provincially accountable organizations.

Decisions regarding the overall direction and mandate of the Deh Cho Travel Connection are typically decided upon through consensus at the twice-yearly general meetings.

Committees:

The ongoing activities and support structure of the Deh Cho Travel Connection is administered by a combination of representative "Leads" from each of the participating jurisdictions (Alberta, British Columbia, Northwest Territories) and by appointed "Committee" members.

The "Leads" serve as the primary contact person on behalf of the jurisdiction and actively work with the Committees and the appointed administrative coordinator in dealing with all ongoing functions and activities.

The Marketing Committee is responsible to implement marketing activities that are established and updated during the general meetings. They are also responsible to review and act upon other additional marketing and promotional opportunities as they arise and agreed to by the majority of the committee members.

The Web Committee is responsible to oversee ongoing improvements and to ensure that the organization's website is current, continues to serve as a responsive marketing aid to the public, and provides an integral communication link for contributing members.

Committees meet twice yearly as part of the general meeting format. As well, regular monthly tele-conference meetings are held. Committees have at least 2 designated representatives from each jurisdiction.

Partners and Funding:

The Deh Cho Travel Connection team consists mainly of staff working for community-based tourism organizations, municipalities, and provincial or territorial government agencies. The team also consists of members who are volunteers and representatives from the community or area Chamber of Commerce, elected municipal or district officials.

Being that the Deh Cho Travel Connection is a marketing coalition, funding contributions are actively solicited from all member partners on a yearly basis to fulfill financial obligations set out in the organization's Marketing Plan. Since the ability of some partners to meet the financial contributions may vary, provisions can be made to allow for in-kind or other value-added remuneration on a short term basis. The consolidated funds may also be used to leverage other third party funding opportunities as they arise.

Administrative Functions:

NWT Tourism continues to provide accounting services to the group as an in-kind contribution and the South Slave Region - Industry, Tourism & Investment (Government of NWT) provides ongoing administrative copydination.

Core Marketing Activities

Website (www.dehchotravel.ca)

"www.dehchotravel.ca" is a principal marketing tool for the Deh Cho Travel Connection. The primary intent of the web-site is to serve as an information gateway for people travelling to the area and to function as a central portal to direct enquiries to your community web-site for their detailed information needs. The 5-year marketing outline identifies the web-site and social media content as priority marketing objectives. The use of these forums is intended to encourage increase traffic to the web-site within a superior user functionality and interactivity

Updates to the web-site in 2012 included a new *Google Maps* styled interactive map, updated photo gallery collection and the launching a *Facebook* page.

Passport Campaign

The Deh Cho Travel Connection is continuing its passport campaign "Diamonds in the Rough" which proves to be a popular quest for travelers and a significant marketing tool for visitor centres and communities on the route. To be eligible for the main prizes travelers are required to obtain 4 stamps from Alberta, 4 from BC and 4 from the NWT, for a total of 12 stamps.

The success of this program can be directly attributed to participating member communities stepping forward with generous donations of the primary and secondary prizes that include a significantly valued diamond, adventure travel excursions and community-based recreational packages.

Brochure

The distinctive "green and gold" fold-out brochure continues to be a popular hand-out at trade shows and visitor centres and provides an invaluable source of information for tourists travelling the Deh Cho Travel Connection. The market committee, visitor centres and participating tourism marketing organizations still foresee a strong demand for the printed brochure and have recommended that we continue to make this marketing product available. The Deh Cho Travel Connection will continue to print information brochures in English, French and German.

The brochure highlights attractions and side trips along the route, features a useful map and distance calculator, and provides charts outlining services available in communities and campgrounds for the traveler.

Consumer Trade Shows

RV shows, Outdoor Adventure and regional consumer trade shows provide a strategic venue for the Deh Cho Travel Connection to "connect" directly with potential travelers within our primary target markets. Shows that have been considered critical to our target marketing segment include: Quartzsite Arizona (US market) and Edmonton RV shows, a presence at several trade fairs within our membership communities.

The Deh Cho Travel Connection also receives broader market exposure at shows that are attended by our partnering Destination Marketing Organizations (Travel Alberta, NWT Tourism, and Northern BC Tourism) and by our various participating regional tourism associations.

Advertising and Promotion

The Deh Cho Travel Connection recognizes that there is significant value to be realized in advertising in key general touring travel publications such as the RV'ers bible, "The Milepost" and western Canada's CAA publication "Westworld". These publications will continue to be the primary media for print advertisement investment.

When other cooperative market opportunities become available, these will be evaluated by the Marketing Committee and a decision will be based on their ability to provide measurable marketing value.

Passport campaign (Diamonds in the Rough)

- Promotional campaign that was introduced in 2008 as means of increasing "foot traffic" at local Visitor Centres and has handed out approximately 4,000 passports to date. To be eligible for the prize draw participants need 12 stamps from communities in BC, Alberta and NWT (from 4 VICs in each region)
- The 2012 program's main sponsor was the City of Yellowknife and they donated a Canadian Diamond (roughly .55 carat in size estimated retail value of \$5,500)
- Secondary prizes were provided by; RV Rental Association of Canada (7-day RV rental package), Bud Country Fever (music festival weekend package in Grande Prairie).

Other Marketing & Promotion;

<u>Community DCTC Postcards</u>: We have designed an assortment of community featured postcards that are individualized for any partnering community. DCTC will coordinate a bulk purchase or provide the graphic file for third party printing.

<u>Display Banners</u>: DCTC will provide a canvas banners to any Visitor Centre wishing to display them. The banner is a general promotional or awareness item that highlights the DCTC route. The main feature on the banner is the DCTC route map. Banners are 24"w by 60"h.

<u>DCTC Rack Cards</u>: The DCTC has designed two rack cards that are intended for use as an awareness pieces that can be given out at trade shows, visitor centres. One card is promoting the Passport contest and the second is general route awareness.

<u>FAM Trips</u>: Familiarization (FAM) trips for travel media and trade are coordinated through our partnering provincial and territorial Destination Marketing Organizations. The FAM trips provide an opportunity for travel writers and trade persons to actually experience the route first hand and to promote it in articles or stories in various media publications, blogs, etc.

<u>Trip Itineraries</u>: The DCTC website now includes two suggested trip itineraries for the route. This online resource is an excellent starting point for travelers planning their vacations and provide a general outline of the wide range of activities and experiences along the route. Trip itineraries are based on a 12-14 day vacation.

Media/Trade Kits: DCTC has a detailed information package that will now be circulated to wide range of media and travel trade outlets providing background information and other material to engage the interest of travel writers, (suggested story-lines, tourism experiences, highlighting special events or festivals). We are also providing this information to the travel trade (bus-tour operators, travel resellers, etc.).





As you know, Peace Library System (PLS) made a presentation to Mackenzie County Council on March 27, 2013. We were joined by Ken Feser from the Public Library Services Branch of Alberta Municipal Affairs, who emphasized the new Public Library Network Policy, the importance of being part of the network for resource sharing purposes, and other provincial services such as Mango and Press Display. He made it clear that the way to be part of the Network was through cooperation and reciprocity, and by being a member of a regional library system.

Within that context, we were hopeful that Mackenzie County Council would choose to join PLS, bring its three libraries into the provincial public library network, and open up new library services to its residents. However, we understand that Mackenzie County Council has referred the matter back to the Mackenzie County Library Board for further study. We will be happy to provide any background data or statistics that you might need as you consider System membership.

In the meantime, the PLS Board believes that it must adhere to the new Public Library Network Policy. Our contract with Mackenzie County Library Board for services to the Fort Vermilion library contravenes the Policy as we are allowing a non-Network participant to access the provincial resource sharing network.

The Public Library Network Policy states:

Any library board in Alberta that is either a designated node, a partner of a node via library system membership, or a partner of a node under pre-existing arrangements (i.e. Fort Saskatchewan), is considered a network participant. Network participants are responsible for (a) fully participating in the network and abiding by the network operational guidelines established by PLSB; and (b) providing necessary capacity to connect to the network including (but not limited to) trained staff, appropriate technology, agreement with suitable Node.

(Please note that the nodes are the seven library systems, and the public libraries in Edmonton, Calgary, Fort McMurray, Grande Prairie, Strathcona County, St. Albert, Red Deer, Lethbridge and Medicine Hat.)

With that in mind, the PLS Board carefully considered the matter and unanimously passed the following motion at its May 11, 2013 meeting:

That the Agreement for the Provision of Access to the Alberta Public Library Electronic Network and Associated Services between Peace Library System and the Mackenzie County Library Board be terminated effective December 31, 2013.

The Agreement between Peace Library System and the Mackenzie County Library Board states that either party may terminate the Agreement by giving six months' notice prior to June 30, to be effective January 1 of the following calendar year. Terminating the Agreement means that Fort Vermilion Community Library would be removed from the Polaris integrated library system at the end of 2013, and that the library would need a different automation system effective January 1, 2014. It also means that library patrons would no longer have access to the provincial resource-sharing network, including TRAC resources. This, of course, would not take effect if Mackenzie County chooses to join Peace Library System prior to the end of 2013.

I would also like to update you on a further decision of the PLS Board. At the presentation to Mackenzie County Council, membership for five of the ten wards had been offered as a temporary option to "ease in" membership for 2013 and deal with the immediate issues at Fort Vermilion and High Level. Please note that the PLS Board passed a motion at its May 11, 2013 meeting that only full membership on behalf of the entire Mackenzie County population be considered in the future.

As you consider the matter of library system membership, please consider some of the benefits to your libraries and residents:

- Services would be equitable for all patrons in the region.
- Your libraries would be part of the provincial public library network. We would work towards full access to the network through Polaris automation.
- All library patrons would be able to borrow from 300+ libraries, including college and university libraries. The books would be sent to a local library (or the library selected by the patron) for pick-up and could be dropped off at any member library.
- Your libraries would offer provincial resources such as Freading (eBooks), Mango (language learning software) and Press Display (hundreds of newspapers worldwide).
- Your libraries would offer access to Auto Repair Reference Center, Small Engine Repair, NoveList, and a host of other electronic resources.
- Your libraries would make eBooks available to patrons through our OverDrive subscription.
- Your libraries would have strong support for IT operations through trained technicians.
- Your libraries would have strong support for library operations through professional librarians.
- PLS professional librarians could help your Library Board meet the legislative requirements for staffing.

We look forward to continuing the conversation concerning System membership. I would like to extend an invitation to your board members to visit Peace Library System headquarters in Grande Prairie at a time that is convenient for you. Although many of our services take place off site – either in the libraries or online – we would be able to give you some sense of core services such as

ordering, cataloguing, specialized collections, and the like. We also would be happy to attend a meeting of your Library Board to provide additional information.



Subject: Update #11 - TransCanada's Northwest System Expansion projects

Please find attached, a project fact sheet providing a status update related to TransCanada's Northwest System Expansion projects. Of the six pipelines and two compressor stations applied for (in 2011) as part of this expansion, four pipelines and both compressor stations have been constructed and are now in service. The Chinchaga Loop pipeline, located approximately 50 kilometres northwest of Manning, Alberta, has been approved and is expected to commence construction in November of this year.

The newly constructed facilities are now operating within TransCanada's Wildrose Region. The community is encouraged to contact the region's Aboriginal and Community Relations Liaison, Peter Knight with any questions related to the ongoing operation and maintenance of these facilities. Peter can be reached by calling (780)297-3731.

The Komie North Extension pipeline was not approved by the National Energy Board (NEB) due to the tolling methodology used within the application. According to the report, the NEB did not feel that there was enough commercial support at this time for this project. While TransCanada has made a decision not to pursue further development of the project at this time, TransCanada continues to believe strongly in the potential of the Horn River Basin. If, in the future, commercial conditions indicate that additional pipeline infrastructure is required, TransCanada will again engage stakeholders and communities, and undertake an environmental assessment in support of a regulatory application.



Since the summer of 2010, TransCanada's wholly-owned subsidiary, NOVA Gas Transmission Ltd. (NGTL), has been engaging stakeholders and Aboriginal communities about a number of pipeline and compressor station projects in northeast British Columbia and northwest Alberta.

TransCanada submitted four applications to the National Energy Board (NEB) for these projects and all projects, with the exception of Horn River Mainline (Komie North Section), and the Fortune Creek Meter Station, have been approved by the NEB. All approved projects, with the exception of the Chinchaga Lateral Loop, have been constructed and are now in service.








Moody Creek and Hidden Lake North Compressor Stations










Horn River Mainline (Komie North Section) and Fortune Creek Meter Station, Chinchaga Loop Section





On January 30th of this year, the NEB issued a report recommending the approval of the Chinchaga Loop Section, but did not recommend approval of the Komie North Section and Fortune Creek Meter Station, based on the tolling methodology used within the application. According to their report, the NEB did not feel that there was enough commercial support at this time for this project. The NEB's recommendation and key conclusions related to this application can be viewed by visiting the NEB's website www.neb-one.gc.ca.

While TransCanada has made the decision to not pursue further development of the Komie North Section pipeline and Fortune Creek Meter Station at this time, TransCanada continues to believe strongly in the potential of the Horn River Basin. If, in the future, commercial conditions indicate that additional pipeline infrastructure is required, TransCanada would again engage stakeholders and communities, and undertake an environmental assessment in support of a regulatory application.

On May 6th, the Chinchaga Loop Section received full regulatory approval. Construction of the 33 km pipeline, located approximately 50 km northwest of Manning, Alberta, is expected to commence in November 2013. Construction preparation activities including preparation of a hydrotest site, and pipe stockpiling will commence this summer. The project will utilize an existing 550 person camp provided by Compass Group Canada, located near the west end of the Chinchaga Loop route. This pipeline is expected to be in service in April 2014.
