


SCHEDULE "A"

BY-LAW No. 020/95

2. That monies required for the repayment of the Fund for both the principal and interest at a rate of nine and one quarter per centum (9 1/4%) per annum shall be raised from the imposition of a local improvement tax levied at a rate of \$8.09 per linear metre of frontage per year for twenty-five (25) years commencing in 1995 on each of the lots benefiting from the installation of this service as set out below, and shall be levied on the annual notice of taxation and shall be payable annually on the date on which the annual tax notice is due and payable, and shall be collectable at the same time and in the same manner as other tax rates;
