

BYLAW NO. 171/99

**BEING A BY-LAW OF THE
MUNICIPAL DISTRICT OF MACKENZIE NO. 23
IN THE PROVINCE OF ALBERTA**

**TO REGULATE THE PLACEMENT OF
TRAFFIC CONTROL DEVICES WITHIN THE
MUNICIPAL BOUNDARIES**

WHEREAS the Highway Traffic Act, Section 16(1)(b), Chapter 7 of the Revised Statutes of Alberta 1980, as amended provides that a Council may by Bylaw delegate to any municipal official or employee the power to prescribe where traffic control devices are to be located, and

WHEREAS those traffic control devices located by that person should be deemed to have been made by Bylaw of the municipality,

AND WHEREAS a record of all the locations to be kept shall be open to public inspection during normal business hours.

THEREFORE by virtue of the powers vested in it under Section 14(6) of the Highway Traffic Act, being Chapter H-7, Revised Statutes of Alberta, 1980 and Amendments, the Council of the Municipal District of Mackenzie No. 23 enacts as follows:

1. This Bylaw shall be cited as "The Traffic Control Devices Bylaw".
2. Definitions
 - (a) "**Act**" means the Highway Traffic Act, being Chapter 7, of the Revised Statutes of Alberta, 1980 as amended.
 - (b) "**Council**" means the Reeve and Councillors of the Municipal District acting as Council at duly assembled meetings.
 - (c) "**Traffic Control Device**" means any sign, signal, marking or device placed, marked or erected under the authority of the Highway Traffic Act, for the purpose of regulating, warning or guiding traffic.
3. The Chief Administrative Officer or designated person be the delegated municipal employee empowered to prescribe where traffic control devices are to be located.

4. The Chief Administrative Officer or designated person shall maintain two (2) traffic control device maps, which shall be considered the official record of locations of traffic control devices. One map shall be in the Municipal Office and the other on display at the Public Works Office.
5. This Bylaw shall take effect on the date of the third and final reading thereof.
