- How will the catch limits be policed?
- Will Fish and Wildlife be able to police, as they are already shorthanded?
- Disappointing to hear that the pelicans are no longer nesting. Users were not respecting the buffer for nesting grounds, and now they are gone. More users will just intensify the problem with the environment.

- With seasonal camping stalls, the number of users will increase. Can the lake sustain that angling pressure?
- Does the campground have a holding tank for sewage?

Some of the information from that report and current costs for the service were used to establish the May 31<sup>st</sup> report.

Administration presented the report to Council at their June 30<sup>th</sup> meeting where Council requested additional information. A resolution was passed requesting a proposal from Aeromedical Emergency Services to increase the service level from Basic Life Support to Advanced Life Support for each community effective January 01, 2006.



During this time, some of the old buildings that did not meet that setback on 100 Street, have be moved or demolished, such as the old Crosstown building, the former La Crete Home Hardware and Imperial Oil. Also in the last 2 years the service road towards the south end of the street has been closed. Recently I realized that the required setback is only 30 feet but I would like to see it changed to 100 feet.

One of the main reasons for having a setback of 100 feet is to better accommodate parking and to eliminate congestion with larger vehicles accessing the street, such as farm vehicles and full size trucks. Having a greater setback also leaves room for future expansion of main street, such as a meridian and turning lanes. We feel that now would be the best time to address this issue.



#### Dear Chief Noskiye:

I am pleased to advise that the Province is prepared to designate the Garden River Road, from the end of the current Highway 58 at the Wentzel River to the Wood Buffalo National Park boundary, as a provincial highway. This designation is subject to the existing construction cost share arrangement being maintained. The Little Red River Cree Nation will be responsible for the total cost of operation and maintenance of the highway for a period of 25 years.

The road will be constructed to an 8 metre graveled width and designed for a 90 kph speed. The funding arrangement for the construction is for my department to pay 100% of the cost from km 7.8 to the Wood Buffalo National Park boundary. Indian and Northern Affairs Canada (INAC) is responsible for 100% of the construction costs from the end of Highway 58 to km 7.8.

It is understood that INAC will fund 100% of the construction of the Fox Lake Road and that this road will be operated and maintained by Little Red River Cree Nation under a Licence of Occupation from Alberta Sustainable Resource Development.

The first mile of Savage Prairie Road was reconstructed in 2001 and the second mile was budgeted for reconstruction in 2005. This project is currently 75% complete. The road was reconstructed and the road top was graveled on August 31, 2005. Easements were secured for backsloping, provided the work would be completed after harvest. Therefore, the finishing will be completed in the next month or two.

The project was budgeted for \$78,000 but due to difficulty in getting dirt fill, the project will go over budget in order for the ditches and backsloping to be completed properly.

The budget for this project is \$39,000 but this project required more fill than budgeted and will also go over budget when it is graveled and culverts put in.

This is a half mile of road in West La Crete identified as a non conforming road that required upgrading to MD standards. This project is complete and under budget.

### **BACKGROUND / PROPOSAL:**

Currently the Municipal District of Mackenzie is accredited for Safety Codes in the Fire, Building, Electrical, Plumbing and Gas Disciplines. The Fire, Building, Plumbing and Gas Disciplines are administered by Safety Codes Officers with MD of Mackenzie. The Electrical Discipline is administered by MD of Mackenzie and inspections are done by Superior Safety Codes Inc.

The fee structure needs to be amended to be cost recovery which on a lot of the permits it currently is not. There is also different items such as camps, annual permits, etc. that we currently do not have in our fee schedule.

As discussed with Council previously, we would bring back a bylaw that would identify our needs for a permanent electrical inspector and a self sufficient fee structure.

Currently the MD gets 20% minus safety codes fees and Superior Safety Codes keeps the remainder.

We realize we can not make each discipline be cost recovery on it's own but by having them all being administered and inspected by our own staff we can provide a cost effective and efficient service for our ratepayers.

By establishing this bylaw it will assist the Mackenzie Region Safety Services Commission when it is established.

### **ANNUAL ELECTRICAL PERMIT PROCESS**

An Annual Electrical Permit may be issued to an establishment that employs a full time qualified Electrician or hires an electrical contractor to perform minor electrical upgrades or renovations (an electrical project value of less than \$10,000.00) on the premises identified on the permit application. Installations over \$10,000.00 in job value require a separate electrical permit.

The establishment shall maintain a current and accurate two-year record of all electrical upgrades or renovations and shall make it available to the MD of Mackenzie upon request. The establishment is responsible for the electrical work required to satisfactorily complete the electrical installation covered by the permit.

A single Annual Electrical Permit may be issued to cover all minor electrical upgrades or renovations performed during a full calendar year or for a lesser period of time when required. The permit fee shall be based on a full calendar year.

MD of Mackenzie will determine the number of inspections to be made on the establishment for which an annual permit has been issued.



#### **BACKGROUND / PROPOSAL:**

Council passed bylaws to close 100 A Street in La Crete as it was not needed after the four-lane street was constructed since adjacent businesses now access 100 Street directly. At their March 8, 2005 meeting, Council passed a motion to sell the subject property to adjacent landowners for \$2 per front foot.

#### **DISCUSSION / OPTIONS / BENEFITS / DISADVANTAGES:**

Since the property was advertised for sale, we have had property owners ask why they should pay any money at all for the subject property since, at the time of subdivision, the developers turned that portion of land over to the MD for \$1.00. The road allowance is of no use to the MD and of little use to the property owners except that it would give them more parking space.

Since we advertised the property for sale we have only had two adjacent landowners show any interest in purchasing the property.

Attached is a letter from Jake Elias, dated October 4, 2002, offering to purchase the adjacent road allowance for \$1.00, the same price the MD paid for it. In his June 27, 2005 email, Mr. Elias states that his offer still stands although he will pay the requested \$2.00 per front foot if Council does not accept his offer.

The property is of no use to a third party as they would have to provide access to the adjacent properties as well as utility easements and it would not meet development setbacks. If we sell the property for a minimal cost, the MD will eventually gain revenue with the added assessment to the adjacent properties.

#### IN THE PROVINCE OF ALBERTA

This bylaw authorizes the Council of the Municipality to incur indebtedness by the issuance of debenture(s) up to a maximum of \$370,000, for the purpose of financing the gravity sewer lane 98<sup>th</sup> Avenue East and 99<sup>th</sup> Street North.

#### WHEREAS:

The Council of the Municipality has decided to issue a by-law pursuant to Section 258 of the *Municipal Government Act* to authorize the financing, undertaking and completion of the gravity sewer lane 98<sup>th</sup> Avenue East and 99<sup>th</sup> Street North as approved by Council in capital expenditures.

Plans and specifications have been prepared and the total cost of the project is estimated to be \$370,000.

In order to complete the project it will by necessary for the Municipality to borrow the sum of \$370,000 for a period not to exceed 10 years, from the Alberta Capital Finance Authority or another authorized financial institution, by the issuance of debentures and on the terms and conditions referred to in this bylaw.

The estimated lifetime of the project financed under this by-law is equal to, or in excess of 10 years.

The principal amount of the outstanding debt of the Municipality at December 31, 2004 is \$8,024,843.59 and no part of the principal or interest is in arrears.

All required approvals for the project have been obtained and the project is in compliance with all *Acts* and *Regulations* of the Province of Alberta.

Borrowing Bylaw for the gravity sewer lane 98th Avenue East and 99th Street North.

## NOW, THEREFORE, THE COUNCIL OF THE MUNICIPALITY DULY ASSEMBLED, ENACTS AS FOLLOWS:

- 1. That for the purpose of completing the gravity sewer line 98<sup>th</sup> Avenue East and 99<sup>th</sup> Street North the sum of THREE HUNDRED AND SEVENTY THOUSAND (\$370,000) be borrowed from the Alberta Capital Finance Authority or another authorized financial institution by way of debenture on the credit and security of the Municipality at large.
- 2. The proper officers of the Municipality are hereby authorized to issue debenture(s) on behalf of the Municipality for the amount and purpose as authorized by this by-law, namely the gravity sewer line 98<sup>th</sup> Avenue East and 99<sup>th</sup> Street North.
- 3. The Municipality shall repay the indebtedness according to the repayment structure in effect, namely annual or semi-annual equal payments of combined principal and interest instalments not to exceed TEN (10) years calculated at a rate not exceeding the interest rate fixed by the Alberta Capital Finance Authority or another authorized financial institution on the date of the borrowing, and not to exceed TEN (10) percent.
- 4. The Municipality shall levy and raise in each year municipal taxes sufficient to pay the indebtedness.
- 5. The indebtedness shall be contracted on the credit and security of the Municipality.
- 6. The net amount borrowed under the by-law shall be applied only to the project specified by this by-law.
- 7. This by-law comes into force on the date it is passed.

Cultural: Fort Vermilion has a rich heritage as being a first community in Alberta and an instrumental participant in the fur trade along the Peace River; La Crete was established by French settlers but prospered with the settlement of Mennonite farmers; aboriginal communities within MD boundaries have held on to much of their Native culture; and, the rural area of Rocky Lane houses many Ukrainians.

Recreational: Various wildlife and breathtaking landscapes in this vast area provide exciting outdoor adventures such as fly-in fishing, guided hunting, bird-watching, historical canoe and boating routes, camping, hiking, and cross-country skiing. Other modern recreational and entertainment facilities are also available.

Social: This region has excellent schools, and most areas of the MD have access to health, emergency, and 911 services.

3. Why is your municipality interested in hosting an intern?

Because of the MD's distance from major city centers, it is difficult to recruit and retain qualified and experienced management personnel. Therefore, the MD fully understands and supports the objectives of this program. This opportunity would provide excellent exposure for the municipality to attract administrators by showing off its excellent career opportunities and rich heritage and resources that make this area particularly exciting to live and work in.

4. Based on the internship Workplan (see Web site), what activities would you have an intern involved with if you were a host?

Most of the activities listed on the workplan can be accomplished at the MD; therefore, the CAO and intern would jointly prioritize items within each functional area depending on the intern's interest and department's situation. As of time of submission, only items related to public transit could not be completed with us and agricultural services could be added if the intern was interested. The MD would ensure the intern was adequately immersed in each functional area.

At the onset of the 12-month period, the MD would hold Council and staff functions to integrate the intern and accommodate activities under *Municipal Government in Alberta*, *Governance*, and *Management*. Within each functional area, the workplan would be conducted to provide both a general introduction to the area and applicable legislation followed by participatory activities.

5. Who is your proposed intern supervisor and what position does your proposed intern supervisor hold (i.e. CAO or Senior Manager)?
