### Old Forestry Base Camp Building Removal

#### Fort Vermilion

#### All proposals must be sent to the Fort Vermilion County Office by 4:30pm on June 30<sup>th</sup>, 2022 Proposals will be reviewed July 7<sup>th</sup>. Accepted proposals will be notified July 8<sup>th</sup>.

#### Purpose

Mackenzie County is requesting proposals to remove the remaining four buildings off of the Old Forestry Base Camp in Fort Vermilion, beside the airport. Companies/ Individuals may propose to remove <u>one or more buildings</u> while choosing one of the following options:

- 1. Propose to remove building(s) with a \$ contribution to the enhancement of the area.
- 2. Propose to fully remove building(s) without cost.
- 3. Remove building(s) for Mackenzie County at proposed cost.

<u>Absolutely no demolition on site</u> unless otherwise approved by the County. <u>Buildings MUST be removed by July 31<sup>st</sup> 2022.</u>
