**BEING A BYLAW OF
THE MUNICIPAL DISTRICT OF MACKENZIE NO. 23
IN THE PROVINCE OF ALBERTA**

A BYLAW OF THE MUNICIPAL DISTRICT OF MACKENZIE No. 23, IN THE PROVINCE OF ALBERTA FOR THE PURPOSE OF CLOSING A PORTION OF A PUBLIC ROADWAY IN ACCORDANCE WITH SECTIONS 22 AND 606 OF THE MUNICIPAL GOVERNMENT ACT, CHAPTER M-26, REVISED STATUTES OF ALBERTA 2000.

WHEREAS, Council of the Municipal District of Mackenzie No. 23 has received a request for a road closure, subject to road closure proceedings being approved, and

WHEREAS, Council of the Municipal District of Mackenzie No. 23 has determined that the road allowance as outlined on Schedule A attached hereto, be subject to a road closure, and

WHEREAS, notice of intention of the Council to pass a bylaw has been published in a locally circulated newspaper in accordance with the Municipal Government Act, and

WHEREAS, Council of the Municipal District of Mackenzie No. 23 was not petitioned for an opportunity to be heard by any person prejudicially affected by the bylaw.

NOW THEREFORE, be it resolved that the Council of the Municipal District of Mackenzie No. 23 does hereby close and sell the road allowance described as follows, subject to the rights of access granted by other legislation or regulations:

1. Meridian 5 Range 16 Township 104 – All that portion of Government Road Allowance adjoining the west boundary of Section 36, which lies north of the production across said Road Allowance of the north-westerly limit of Road Plan 1178PX and which lies southwest of the curvilinear north-westerly production of the westerly limit of Road Plan 1178PX across said Road Allowance, a width of 20.1 metres (66 feet) and a mean length of 1174.13 metres (3852.13 feet), a total area of 2.36 Ha (5.835 acres) excepting thereout all mines and minerals, be subject to a road closure.
2. That this Bylaw shall come into effect upon the passing of the third and final reading of this Bylaw.

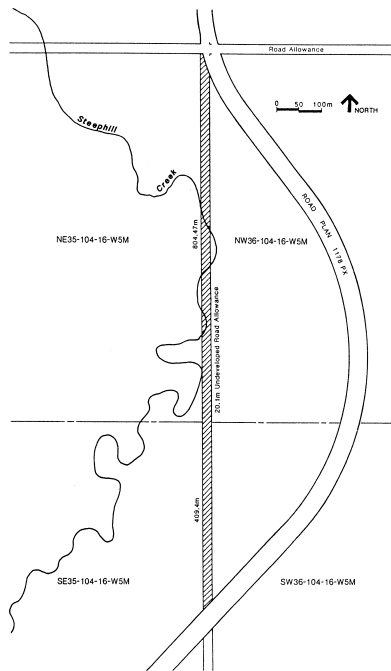
